

Nomadic community from UP urges Centre to grant ST status

NEW DELHI, APRIL 1 /--/ Members of the 'Banjara' (nomadic) community from Uttar Pradesh on Monday urged the central government to include it in the Scheduled Tribes list. At an event, representatives of the community submitted a request to Union Tribal Affairs Minister Jual Oram, who immediately forwarded it to the ministry's secretary for further action. Om Prakash Nayak, a member of the Uttar Pradesh Commission for Scheduled Castes and Scheduled Tribes, said the community is classified as a Scheduled Caste in some states and a Scheduled Tribe in others. "But in Uttar Pradesh, our demand has been pending for a long time. Several proposals were submitted to the Centre but the Registrar General of India (RG) did not support them, citing the absence of our community in the 1931 census," Nayak said. (PTI)

SC refuses to hear fresh plea over 1991 Places of Worship Act

NEW DELHI, APRIL 1 /--/ The Supreme Court on Tuesday refused to hear a fresh plea challenging the validity of a provision of the Places of Worship (Special Provisions) Act, 1991, which mandates maintaining the religious character of a place as it existed on August 15, 1947.

There are over six petitions, including the lead one filed by lawyer Ashwini Upadhyay, challenging various provisions of the 1991 law already pending adjudication in the top court. On Tuesday, a bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar was urged by Nitin Upadhyay, a law student, that his plea be also heard alongside pending ones. "We are not inclined to entertain a fresh PIL under Article 32 of the Constitution," the CJI said. The bench, however, permitted the law student to file an interim plea for intervening in pending petitions. The 1991 law prohibits conversion of any place of worship and provides for the maintenance of the religious character of any place of worship as it existed on August 15, 1947. However, the dispute relating to the Ram Janmabhoomi-Babri Masjid at Ayodhya was kept out of its purview.

Upadhyay sought the apex court's direction allowing courts to pass appropriate orders to ascertain the original religious character of a place of worship.

It has challenged Section 4(2) of the Act that barred proceedings to change the religious character, besides prohibiting filing of fresh cases for the same. "The Centre has transgressed its legislative power in barring the judicial remedy, which is a basic feature of the Constitution.

कोलकाता, 1 अप्रैल (निरा)। पाथरप्रतिया में पटाखा फैक्ट्री में हुए विस्फोट की जांच पर एनआईए से कार्रवाई जारी चाहिए। केंद्रीय राज्य मंत्री और भाजपा के प्रदेश अध्यक्ष सुकान्त मजुमदार ने आज यह मांग की। नवनाब ने भी घटना पर रिपोर्ट तलब की है। सुकान्त मालवहार को अपने लोकसभा क्षेत्र बारासघर से सरकार मांस से बगामोडिया हवाई अड्डा पहुंचे। वहां से वह टिड्डी के लिए नवाना गए। बागडोया हवाई अड्डे पर फरकानों से बात करते हुए उन्होंने पाथरप्रतिया में एक पटाखा फैक्ट्री में हुए विस्फोट के तिलसिले में राज्य की कानून-व्यवस्था की स्थिति पर चिन्ताना सभा। इस दिन सुकान्त मजुमदार ने कहा, राज्य में हर दो से तीन महीने में ऐसी घटनाएं देखने की मिलती है। मुख्यमंत्री ने राज्य को बाइर की डे पर खड़ा कर दिया है। इस घटना में मुकाम बनो विरोधी ताकत शामिल है या नहीं, इसकी जांच जरूरी है। मामला बनजी की प्रणाल से दक्षिण 24 परगना पूरी तरह से डिहाइल हो है। हमारा बनजी की आग उसर 24 परगना में जिहादीकरण चल रहा है। इसमें जमतत और बांलाओटी ताकतों के बीच संबंध हो सकते हैं। इसकी जांच हमेंनी चाहिए। मैं टिड्डी लोटी के बाद मालनीय गृह मंत्री अमित शाह को पत्र लिखकर जांच का अनुरोध करूंगा। जरूरत पड़ने पर एनआईए जांच कार्रवाई जानी चाहिए। इसके बाद उन्होंने घटना के लिए पुलिस प्रशासन को जिम्मेदार ठहराते हुए कहा कि इस घटना के बारे में सभी को पता था। दूसरी ओर, नवाना सूत्रों के अनुसार, पाथरप्रतिया की घटना को लेकर मुख्यमंत्री ममता बनर्जी काफी चिंतित हैं। वह स्वयं घटना की जांच पर नजर रख रहे हैं। उनके आदेश पर नवाने ने इस मामले पर जिला मजिस्ट्रेट से रिपोर्ट तलब की है। प्रशासनिक सूत्रों के अनुसार, घोषाहाट, पाथरप्रतिया में पीपी आबादी वाले इलाके में लंबे समय से अवैध पटाखा फैक्ट्री चल रही थी। आरोप है कि वह पटाखा फैक्ट्री एक दशक से भी अधिक समय से बिना किसी प्रशासनिक निगरानी के चल रहा था। इस घटना में केवल चंद्रकांत बनिक और तुषार बनिक को गिरफ्तार कर लिया गया है। सरकारी सूत्रों के अनुसार गिरफ्तार चंद्रकांत की पुराछाड़ रिपोर्ट भी नवाना को भेजी जाएगी। इस बीच, इस घटना से राज्य की राजनीति में फिर से सर्रायाई बढ़ गई है। दूसरी ओर, स्थानीय निवासियों का आरोप है कि पुलिस का एक वर्ग अपने कारखानों की गतिविधियों का समर्थन कर रहा है। स्थानीय निवासियों ने दावा किया कि पुलिस नियमित रूप से कारखानों मालिकों से फैसे लेती है। विपक्ष इस बात पर फुकर है कि कैसे ये कारखाने प्रशासन की नाक के नीचे संचार रूप से चल रहे हैं।

राज्यपाल कर सकते हैं पाथर प्रतिमा का दौरा

कोलकाता, 1 अप्रैल (निरा)। दक्षिण 24 परगना जिले के पाथर प्रतिमा इलाके में हुए भीषण विस्फोट में आज लोगों की मौत पर राज्यपाल सी.वी. आनंद बोस ने गहरा शोक व्यक्त किया है। उन्होंने कहा कि इस तरह की घटनाओं की पुनरावृत्ति रोकने के लिए आवश्यक कदम उठाए जाएंगे। सोमवार रात घोषाहाट इलाके में एक घर में हुए इस विस्फोट में चार बच्चे समेत आठ लोगों की जान बली गई। पुलिस का दावा है कि यह एक गैस सिलेंडर विस्फोट था, हालांकि इस घटना को लेकर कई तरह के संदेह भी जाता जा रहा है। स्थानीय जनसूचना विभाग के कहे हैं कि इस घर में पटाखा बनाया जा रहा था जिसकी वजह से विस्फोट पैदा। राज्यपाल बोस ने कहा कि घटनाएं जिस संयोग नहीं होती। इनके पीछे कहीं न कहीं मानवीय चूक होती है। इन घटनाओं को रोकने और संबंधित कानूनों को लागू करने की प्रथमिक जिम्मेदारी सरकार की होती है। अधिकारियों को अवैधकरण सतर्क रहना चाहिए और इस दिशा में अधिक सक्रिय कदम उठाने चाहिए। उन्होंने पीठा हाथीरियों के प्रति संवेदना जताते हुए कहा कि प्रशासन को सहाय कि वक स्थिति पर गौरव है कि मनीष में ऐसी घटनाएं न हों। राज्यपाल ने कहा कि वह स्थिति की समीक्षा के बाद पाथर प्रतिमा का दौरा करने पर विचार कर सकते हैं।

Badlapur accused death: Maharashtra DGP to constitute SIT, says SC

NEW DELHI, MAY 5 --/ The Supreme Court on Monday said Maharashtra's Director General of Police (DGP) will constitute an SIT to probe allegations against five policemen for the custodial death of Akshay Shinde, the accused in Badlapur sexual assault case.

Shinde, accused of sexually assaulting two minor girls at a school in Badlapur in Thane district, was allegedly shot in a police van on September 23, 2024, when he was being taken to Kalyan from the Taloja prison for questioning in another case. An apex court bench of Justices Bela

M Trivedi and Prasanna B Varale passed the order on a plea filed by the Maharashtra government challenging the Bombay High Court's April 7 ruling. The High Court had ordered an FIR against five policemen for Shinde's custodial death and the setting up of a special investigation team under the supervision of Lakhmi Gautam, joint commissioner of police, crime, Mumbai.

Modifying the High Court's direction, the apex court said the Maharashtra DGP would constitute the SIT which would continue the probe. Solicitor General Tushar

Mehta, appearing for Maharashtra, said the state has no objection to the setting up of an SIT but it should be constituted under the supervision of the DGP. The top court said if the complainant can approach the concerned trial court if he has any grievance. A division bench of the High Court had rapped the Maharashtra government for its "reluctance" to lodge an FIR, stating that such action undermines the state's legitimacy and the common man's faith in the criminal justice system. When a prima facie offence is disclosed, it is mandatory to lodge a case, the bench noted. The

High Court said it was satisfied that the case required a thorough investigation as it was undisputed that the deceased succumbed to bullet injuries inflicted by a police officer when he was in police custody.

Shinde's parent claimed their son was killed in a fake encounter. The escorting police team claimed they had shot at Shinde in self-defence after he snatched the gun of one of them and opened fire. A magistrate inquiry report, however, dismissed their argument and indicted five police personnel. (PTI)

Pak would be 'wiped out' if it continued anti-India operations: BJP’s Anurag

HAMIRPUR, MAY 5 --/ Former Union Minister and BJP leader Anurag Thakur on Monday lashed out at Pakistan for "fomenting troubles" on the borders and said that if Pakistan continued with such anti-India operations, it would be "wiped out".

The BJP leaders in Shimla submitted a memorandum to the deputy commissioner, urging him to immediately identify the Pakistanis living here both legally and illegally and ensure that they are sent back. The BJP workers and leaders also took out a protest march in the Lower Bazaar area of the town, raising anti-Pakistan slogans. Himachal Pradesh BJP chief Rajiv Bindal said Pakistanis cannot be kept in the state and protests are being held at 17 places in

the state. If the state government did not identify Pakistanis living in the state and ensure their repatriation, the BJP would launch a 'Jagaran Abhiyan' in the coming days, he said.

Addressing a district-level rally organised by the party at Gandhi Chowk here to protest against the terrorist attack on tourists at Pahalgam in Jammu and Kashmir, which claimed at least 26 lives, Thakur said that the Union Government has made it clear that a befitting reply would be given at the right time. He said that if Pakistan continued with anti-India operations, it would be "wiped out" from the world polity. In view of the brutal killings in Pahalgam, the Narendra Modi government has taken many diplomatic steps against Pakistan,

including the decision to send back Pakistani citizens living in India officially or unofficially, Thakur, the sitting MP from Hamirpur Lok Sabha said.

This work is going on at a rapid pace in many states, but sadly the Congress government in Himachal Pradesh is not at all serious about finding and sending back the Pakistani citizens living in Himachal and therefore, the party decided to protest at every district on Monday, he said. Thakur said that on one hand, the Congress is extending its support to the government's decision to ban various facilities to Pakistan while on the other, its leaders are still making "irrelevant statements". Protests were also held in Kullu, Una, Lahaul and Spiti and other places in the state. (PTI)

Leaders condemn temple desecration in Pune; BJP targets Supriya Sule for ‘soft response’

MUMBAI, MAY 5 --/ Leaders across political parties have deplored the alleged desecration of an idol at a temple in Maharashtra's Pune district and demanded stern action against those involved.

In a post on X on Sunday, NCP (SP) leader and Lok Sabha member Supriya Sule urged the Maharashtra government to act decisively. "A young man has committed an inappropriate act at the Annapurna Devi temple in Paud village. This incident is extremely disgusting and infuriating. No sensitive person can possibly tolerate such behaviour," she wrote in the post. A 44-year-old man was arrested and his 16-year-old son detained after the latter allegedly desecrated the idol in Paud village, police had said earlier.

"I urge the government to take the strictest possible action against him immediately. We firmly believe that no one who disrupts social harmony should be spared or forgiven," said Sule, who represents the Baramati Lok Sabha seat.

Shrirang Barne, Shiv Sena MP from Maval, also labelled the desecration a deliberate act aimed at hurting Hindu sentiments. "We will not tolerate the

insult of our religion," Barne said. "This is not just the act of an unstable individual but a conscious attempt to provoke. A bandh has been called in Mulshi Taluka, and it has received support from the Hindu community. We firmly demand the harshest punishment for the guilty," Barne said on Sunday. However, the condemnation by political parties took a different turn on Monday when BJP MLC Chitra Wagh attacked Sule for not "naming" the accused. In a post on X, Wagh accused Sule of indulging in appeasement politics and not showing the same sensitivity she often does on international issues.

"What's the matter, elder sister of Baramati? You usually put on a show of being extremely sensitive, passionately expressing your views even on matters like the Russia-Ukraine war.

But when a disgusting and outrageous incident occurred in your own constituency, all you did was post a four-line tweet and stay silent," asked the BJP leader. Wagh called the alleged desecration a message threatening Hindu women. She said the Hindu community "may never be able to forgive" Sule for her "silence". (PTI)

ED making bald allegations: Apex court on bail plea of accused in Chhattisgarh liquor scam

NEW DELHI, MAY 5 --/ The Supreme Court rebuked the Enforcement Directorate on Monday for making allegations against an accused in a liquor scam case "without any evidence" and said it has become a pattern.

A bench of Justices Abhay S Oka and Ujjal Bhuyan was hearing a petition filed by Arvind Singh seeking bail in the alleged Rs 2,000-crore liquor scam in Chhattisgarh. "This is a pattern adopted by the ED in a number of cases. You just make allegations without any evidence. The prosecution won't stand before the court in this manner," the bench said. During the hearing, Additional Solicitor General (ASG) S V Raju alleged that Singh had earned Rs 40 crore in collusion with another man named Vikas Agarwal. When the court asked, if Agarwal had been made an accused, Raju replied that he was absconding. The bench said: "You have made a specific allegation that he (Singh) earned Rs 40 crore. Now you are not able to show the connection of this man with this or any other company. "You should

state whether he is the director of those companies, whether is a majority shareholder, whether he is Managing Director. Something has to be there," the court said.

Raju said a person can be controlling a company but does not necessarily have to be responsible for the conduct of the company. The Supreme Court said the agency was making a bald allegation. The matter is now posted for hearing on May 9. The apex court had on April 28 pulled up the Chhattisgarh government and asked how long it would keep an accused in jail in connection with the liquor scam case filed by the state authorities. It had noted that three charge sheets were filed in the matter and the investigation was still underway. "Investigation will go on at its own speed. It will go on till eternity. Three charge sheets have been filed.

You are virtually penalising the person by keeping him in custody. You have made the process a punishment. This is not some case of terrorist or triple

murder," the bench had remarked orally. The state had opposed the bail pleas and submitted that the accused need to be confronted with the other accused in the case.

Appearing for the accused, senior advocate Siddharth Agarwal had argued that three charge sheets have been filed in the case and charges are yet to be framed. The apex court allowed Arvind Singh and Amit Singh, to be confronted with former Excise Minister Kawasi Lakhma and posted the matter for May 9. The Enforcement Directorate has alleged that the scam was perpetrated by a syndicate of high-level state government officials, private persons and political executives that generated more than Rs 2,000 crore in tainted money in 2019-22. The money laundering case stems from a 2022 Income Tax department charge sheet filed in a court in Delhi. The ED alleged that bribes were collected from distillers in the state on a per liquor case basis procured from the CSMCL (state body for purchase and sale of liquor) and country liquor was being sold off the books. According to the federal probe agency, bribes were taken from distillers to allow them to form a cartel and have a fixed market share. (PTI)

Chhattisgarh: 2 STF personnel injured in IED blast during anti-Naxal operation

BIJAPUR, MAY 5 --/ Two personnel of the Special Task Force (STF) were injured after an improvised explosive device (IED) planted by Naxalites went off in Chhattisgarh's Bijapur district, where a massive operation against ultras has been underway for two weeks, police said on Monday.

The operation, 'Mission Sankalp', involving about 24,000 security personnel on sprawling hills of Karregutta and adjoining hills along the Chhattisgarh-Telangana border, was launched on April 21 to track down hardcore Naxalites. Two STF jawans sustained minor injuries in the blast on Sunday, an official said. He said, "The injured jawans were administered treatment at a local hospital and were later referred to a higher centre." With this, six security personnel, including one belonging to CRPF, have been injured in IED blasts during the operation, the official said.

The operation, one of the biggest counter-insurgency actions launched in the Bastar region, involves personnel of different units, including the District Reserve Guard, Bastar

Fighters and STF of the Chhattisgarh police, the Central Reserve Police Force and its elite Commando Battalions for Resolute Action (CoBRA).

The operation is underway on the inaccessible terrain and dense forest spread across 800 sq km on both sides of the interstate border Bijapur (Chhattisgarh) and Mulugu and Bhadradri-Kothagudem (Telangana), over 450 km away from Chhattisgarh's capital Raipur. "The operation has reached its climax, and so far, around 75 per cent of the area has been cordoned off and demined. The final phase of the operation is likely to conclude by the end of this week," a senior official monitoring the operation told news agency PTI. He said: "The outcome of an anti-Naxal operation is not only determined by the number of Naxalites killed or weapons recovered. Clearing the area from the captivity of the banned Maoist outfit and making the land safe

again for the native population is also an important objective of the operation." On April 24, three women Naxalites were killed on Karregutta hills, and a huge cache of weapons, explosives and other materials was recovered during the operation.

The official said the area, which is surrounded by dense forests and a range of hills, is considered the safe hideout of Maoists' PLGA (people's liberation guerrilla army) battalion No. 1, the strongest military formation of Maoists. He said the inputs suggested more than 500 Naxalites belonging to PLGA battalion No. 1, Telangana state committee and Dandakaranya Special Zonal Committee (DKSZC) of Maoists led by their hardcore and dreaded leaders, including Central Committee Members Chandrana, Ramachandra Reddy, Sujatha and Hidma, PLGA battalion commander Barse Deva, had gathered for a meeting and were holed up in the area. (PTI)

Rabies claims life of 7-year-old girl in Kerala despite treatment

THIRUVANANTHAPURAM, MAY 5 --/ A seven-year-old girl, who contracted rabies despite receiving vaccination after the dog bite, died at a state-run hospital on Monday, hospital sources said.

The victim, Niya Faisal, a native of Kunnicoode in the neighbouring Kollam district, had been on ventilator support at the Sree Avittom Thirunal (SAT) Hospital here for a few days after she tested positive for rabies infection. This is the third rabies-infection-related child death in the past month in the state, despite receiving post-bite rabies vaccinations following stray dog attacks. Niya's tragic death happened just days after a six-year-old girl in Malappuram district, Ziya Faris, died of rabies despite having received vaccination. A 13-year-old girl, hailing from Pullad in Pathanamthitta, also succumbed to the infection recently even after receiving prescribed vaccine doses, sources said. While shifting her body from the hospital, Niya's wailing mother said on Monday morning that no other child should suffer such a tragedy. "A large pile of waste is dumped near our home. We repeatedly asked people not to do this, but no one listened to our pleas. Stray dogs, attracted by the waste, mauled my daughter in front of me," she told reporters here. Stray dogs were seen freely entering even SAT hospital premises and where is the safety for the children coming there for treatment, she asked. The relatives didn't take the deceased girl's body to her home in adherence with quarantine protocols and buried it in her native village. SAT

hospital authorities later told reporters here that vaccines cannot be blamed in such cases. S Bindhu, superintendent, SAT Hospital, said there are chances for the virus to infect the brain before the vaccine antibody becomes effective, depending on the position and intensity of the dog bite, and it might have happened in Niya's case also. "The girl suffered deep wounds, especially in those places where the nerve density is high. If she suffered a bite on the nerves, the virus would have reached the brain before the vaccine became effective," another senior doctor said.

Multiple bites and deep wounds, especially in areas like the face, neck and hands, where the nerve density is high, increase the chances of infection before the vaccination becomes effective, they explained. While replying to a question, the doctors said in a public health system, it was not right to say that vaccines are ineffective. The vaccines are administered as per standard guidelines, and concerned persons in the health sector are trained to give it in accordance with them, they added. (PTI)

कार के साथ रैसिंग में दो युवकों की मौत, दो घायल एक ही बाइक पर चारो थे सवार

कोलकाता, 5 मई (नि.प्र.)। उल्टाडांगा फ्लाईओवर पर आज सुबह एक भीषण सड़क हादसे में दो युवकों की मौत हो गई, जबकि दो अन्य गंभीर रूप से घायल हो गए। घटना सुबह करीब 5:30 बजे की है, जब चार युवक एक ही बाइक पर सवार होकर ईएम बाइपास की ओर से तेज रफ्तार में जा रहे थे। पुलिस सूत्रों के अनुसार, चारों युवकों ने हेलमेट नहीं पहन रखा था और वे एक कार के साथ रैसिंग कर रहे थे। इसी दौरान बाइक अचानक अनियंत्रित होकर फ्लाईओवर के लेकटाउन की ओर जाने वाली लेन में रैसिंग से टकर गई। जोरदार टक्कर के बाद चारों युवक फ्लाईओवर पर ही सड़क पर जा गिरे। स्थानीय लोगों की सूचना पर लेकटाउन थाने की पुलिस मौके पर पहुंची और घायलों को अस्पताल पहुंचाया। डॉक्टरों ने दो युवकों को मृत घोषित कर दिया, जबकि बाकी दो की हालत गंभीर बनी हुई है और उनका इलाज जारी है। गौरतलब है कि महज पांच दिन पहले ही मां फ्लाईओवर पर इसी तरह की एक दुर्घटना में एक युवक की मौत हो गई थी। उस हादसे में भी तेज रफ्तार के चलते युवक बाइक से गिरकर करीब 200 मीटर दूर जा गिरा था और मौके पर ही उसकी मौत हो गई थी।

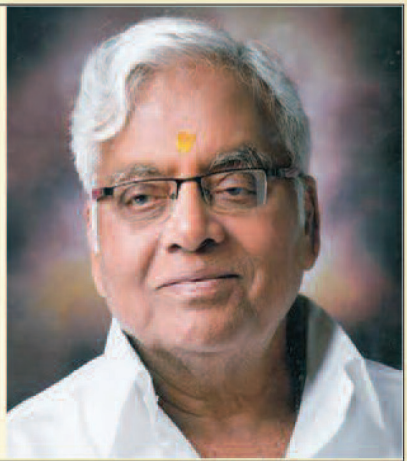
